DOVER – On Wednesday, **House Speaker Melissa Minor-Brown** and **Senate President Pro Tempore Dave Sokola** announced committee assignments for the newly created special committees tasked with investigating Delaware's first statewide property reassessment in more than two generations.

The special committees, formally <u>announced by Democratic leadership</u> last week, will hold a series of public hearings this fall to review the recent reassessment process and consider

potential legislative action to improve the process, as well as explore options to provide targeted tax relief for Delawareans.

"We know that there are still a lot of unanswered questions about the reassessment product both for Delawareans and for lawmakers. These committees are about finding those answers and putting together a thoughtful roadmap that we can act on in the coming legislative session," said **Speaker Melissa Minor-Brown.**

"Although significant challenges lie ahead, I am encouraged that our appointees, with the expertise and representation from all corners of the state, are prepared to move forward without delay."

"We selected the Senate committee members based on a combination of geographic bala and housing and land use policy experience. These legislators have shown extraordinary care and diligence on this matter since we first were alerted to problems for our constituents," said **Senate Majority Leader Bryan Townsend.**

"I look forward to putting our heads down and working together over the coming month really drill down on what happened, and make recommendations about how we can mo forward on behalf of the people of Delaware."

Hearing #1: Week of September 22, 2025

Topics: The Recent Reassessment

Discuss potential for different tax rates based on property type (residential, commercial, agricultural, industrial).

Discuss potential for different tax rates based on size within categories (small vs. large business, small vs. large agricultural). Discuss different housing categories (homeowners, small rentals, large rentals, manufactured homes, second homes).

Drill down on county capacity to adopt differentiated categories or tax rates within categories.

Update on the implementation of August 12 legislation.

Hearing #3: Week of October 20, 2025

Topics: Delawareans and their property taxes

What other considerations might drive changes to Delaware's property tax framework?

What programs are in place to protect Delawareans experiencing economic hards or on fixed income?

How do these programs compare to other states' offerings?

What updates to property-tax exemptions should occur given the first-in-40-year reassessment?

Update on implementation of August 12 legislation.

Hearing #4: Week of November 3, 2025

Topics: Reassessments and Education Funding

How does ongoing property reassessment relate to education funding with Delaware's current funding system and to the legal settlement in the Court of Chancery case that sparked the 2024 reassessment?

Discuss the work of Delaware's Public Education Funding Commission and others to identify optimal coordination of efforts relating to education funding.

Each meeting will take place in the House or Senate Chamber in Legislative Hall. All meetings will be open to the public and will be livestreamed at <u>Clegis.delaware.gov</u> . Additional details about the hearing schedule and opportunities for public engagement will be announced in the coming days.
